

## PATIENT SEDATION

Nursing Personnel manage patients receiving sedative or analgesic medications undergoing invasive diagnostic or therapeutic procedures. Joint commission standards, ASA classifications, AANA and ASA guidelines for medication administration, patient monitoring, discharge instruction, family teaching and patient safety concerns are critical care elements reviewed.

This workshop discusses interventions to correct partial and complete airway obstruction, identifies side effects and contraindications to medication that have the potential to suppress patient's protective reflexes and respirations and outlines ways to effectively manage complication which might arise during moderate sedation.
